How are my rates calculated?

The Council calculates how much money is needed in General Rates to provide the services and programs that our community needs.

The total amount of money to be raised in General Rates is divided by the total value of all rateable properties in the Huon Valley municipal area. The resulting figure is the "rate in the dollar".

The value of a property is used as the basis for calculating what each property owner will pay. Property values are determined by the OVG.

Rates are charged on all rateable properties in accordance with Division 9 of the *Local Government Act 1993* (the Act). The Council uses the Capital Value (land and improvements) as the valuation base in accordance with Section 49 of the *Valuation of Land Act 2001*.


Council sets a General Rate and a minimum amount payable in accordance with Section 90 of the Act. Council applies a variation to the general rate for commercial and industrial properties under Section 107 of the Act based on the predominant use of a property. The Land Use classification is determined by the OVG.

Fresh Property Valuation (Revaluation)

The Office of the Valuer General (OVG) has revalued all properties in the Huon Valley and a Notice of Valuation has been issued to you directly by the OVG.

The revaluation is a statutory requirement in accordance with the *Valuation of Land Act 2001* and occurs every six years. Due to COVID-19 the scheduled revaluation was delayed for 2021 and is now effective from 1 July 2022.

Key highlights of the 2022/2023 Budget are:

- In response to community feedback an extra \$945,000 will go towards the maintenance of unsealed and sealed roads (a 55 per cent increase)
- investment of \$674,000 to strategic planning and town planning
- internally, an investment of \$150,000 into leadership and culture to increase business performance
- a further \$61,000 will be invested in ICT security and backup arrangements given the increasing cyber security risks
- \$47,000 invested in Communications to further improve our engagement and connection with the community
- \$47,000 in a strategic review of Children's Services to ensure the services are keeping up with the needs of families in the Valley
- Council's continued support of medical services despite the operational and financial challenges being experienced
