Pursuant to the powers contained in Section 22 of the Local Government Act 1993 the Council hereby delegates the exercise and performance of the following functions and powers to the General Manager or a person acting in that capacity on the following general conditions of delegations:

- (i) Each delegation is subject to the conditions or limitations (if any) referred to in the table to this delegation.
- (ii) Each delegation is subject to such policies, policy guidelines and directions as the Council may from time to time approve.
- (iii) Each delegation is subject to the Council's By-laws or the provisions of any Act.
- (iv) Each delegation is subject to the General Manager having obtained and taken into account advice of a qualified person in the same manner as if the Council or a Council Committee was making a decision on any particular matter as required by Section 65 of the Local Government Act 1993.

For the purposes of this delegation or any delegation made by the General Manager to an employee of the Council as referred to in paragraph (v), the General Manager or the employee may rely upon their own advice if they have the qualifications or experience necessary to do so as required in Section 65(1) of the Local Government Act 1993.

(v) The General Manager is authorised pursuant to Section 64 of the Local Government Act 1993 to further delegate such functions or powers to an employee of the Council.
